

**RESOLUTION 2023-25**

WHEREAS, the Borough of Waynesboro, from time to time, may adopt new fees and/or change fees charged for Borough services, and

WHEREAS, many of the enabling Ordinances permit the adoption of fees by Resolution,

NOW, THEREFORE BE IT RESOLVED, that the following fee schedule is hereby established and/or modified:

- 1) Transient Retail License (excepting, however, those individuals exempted from paying the fee as noted in the Waynesboro Borough Peddling and Soliciting Ordinance ..... \$20.00/day or \$35.00/year
- 2) Extra Trash Bag Tags ..... \$3.00 each
- 3) Past Due Refuse Bills .....
  - Refuse bills thirty (30) days past due will be assessed a 10% penalty.
- 4) Electronic Recycling Fee ..... \$3.40/year
- 5) Dog Park License ..... \$5.00 (lifetime)
- 6) Tattoo Establishment Inspection/License ..... \$106.00/visit\*

\*Fee is charged per visit for each annual inspection (pass or fail); if failed, additional \$100 fee would be charged for each return trip.
- 7) Dumpster, Roll-off Dumpster and Mobile Storage Unit Permits .... \$25.00/week
- 8) Weekly Curbside Dumpster Permits ..... \$100.00/year
- 9) Tractor-Trailer Parking Permit ..... \$75.00/year
- 10) General Accessible Parking Spaces ..... \$343.00
- 11) Reserved Accessible Parking Spaces ..... \$357.00
- 12) Permanent "No Parking" Signs ..... \$120.00
- 13) Use of Barricades for Non-Emergency Street Closures (including parades, runs and festivals) .....\$300.00 Deposit\*

\*Deposit will be refunded if cones/barricades are picked up at original location of drop-off.

	• Parked within 20’ of Crosswalk at Intersection .....	\$20.00 (ticket)* \$50.00 (fine)
	• Parked in Excess of 12” from Curb .....	\$15.00 (ticket)* \$15.00 (fine)
	• Parked Against Traffic .....	\$15.00 (ticket)* \$15.00 (fine)
	• Parked in Handicap Zone .....	\$50.00 (ticket)* \$200.00 (fine)
	• Other Violation .....	\$15.00 (ticket)* \$15.00 (fine)

\*Any person and/or entity violating any of the parking regulations of the Borough of Waynesboro may be issued a ticket in the amount set forth, payable within 72 hours from the date of issuance. In the event that the violator pays the ticket more than 72 hours but within 10 days from the date of issuance, the violator shall pay double the ticket amount. In the event that the ticket is not paid within 10 days from the date of issuance, a citation shall be filed with the Magisterial District Judge and the violator, upon conviction thereof, shall be guilty of a summary offense and sentenced to pay a fine of no more than the fine amount set forth and costs of prosecution. Each day and/or each violation by the same person and/or entity shall be considered a new and separate violation. (Ref. Ordinance #1140)
