## AFFIDAVIT OF NON-RENTAL INFORMATION

If you are the owner of a property in the Borough of Waynesboro which is currently being occupied by relatives or others but you are not collecting rent or other monetary compensation you may submit an affidavit of non-rental.

The affidavit of non-rental is a sworn affidavit meaning that any statements made within are subject to the penalties of perjury. It must be notarized before it will be accepted by the Office of Zoning and Code Enforcement.

Ord. No. 1197, Chapter 213 of the Code of the Borough of Waynesboro requires that any person offering for rent a residential dwelling unit therein must obtain a business privilege license from the Office of Zoning and Code Enforcement. You are not entitled to collect rent without a Rental License.

Any person found to be in violation of any section of the rental license requirement is subject to a fine of not more than \$1,000.00 per day or imprisonment for a term not to exceed 30 days, or both, at the discretion of the court. Each day that a violation continues shall be deemed as a separate offense.

Once you have filed an affidavit of non-rental you must contact the Department within **ten** (10) **days** to notify them of any changes in contact information, occupancy, and/or monetary arrangement and obtain the proper license(s) if necessary.

If you have filed an affidavit of non-rental and receive a Notice of Violation from the Office of Zoning and Code Enforcement stating that you need to obtain a rental license, read the notice carefully and follow the instructions contained therein.
