This project is funded by the Pennsylvania Department of Community & Economic Development (DCED), Commonwealth Financing Authority (CFA) and the Multimodal Transportation Fund Grant. Pennsylvania State Prevailing Wages shall apply to this contract. The Contract Documents contain requirements addressing prevailing labor wage rates, labor standards, non-discrimination in hiring practices, goals for minority and female participation, MBE, DBE and WBE participation, participation by Section 3 residents and businesses, and related matters.
