LARGE ITEM PICK-UP WILL ALSO BE COLLECTED ON AN "EVERY OTHER WEEK" BASIS ON <u>RECYCLING WEEKS</u>. (See above schedule).

TREE TRIMMINGS, HEDGE TRIMMINGS, BRUSH AND SIMILAR ITEMS ARE COLLECTED ON AN "EVERY OTHER WEEK" BASIS ON <u>NON-RECYCLING WEEKS</u>. Tree trimmings, hedge trimmings, brush and similar items must be tied in bundles not exceeding four (4) feet in length and fifty (50) pounds in weight or placed in a container not larger than thirty-two (32) gallons, separate from other refuse. If these items are in excess of the three (3) container maximum permitted for regular trash, the Contractor may charge a per bundle or container fee for additional items.

GRASS CLIPPINGS ARE COLLECTED ON A WEEKLY BASIS by the Contractor if they are in containers not exceeding thirty-two (32) gallons and placed in containers separate from other refuse. Grass clippings will be considered in the three (3) container limit imposed.

Customers of Waste Management Enjoy Single-Stream Recycling. All of your recyclables can be placed together in the same bin! No sorting required!

The following can be mixed all-together:

- Cardboard (all grades).
- Aluminum food and beverage containers with food debris removed. <u>Labels do not need to be removed.</u>
- Natural and pigmented plastic narrow-neck containers with symbols 1, 2, 3, 4, 5, 6, 7 (milk bottles, water bottles, detergent bottles, shampoo bottles, bleach bottles, etc.) Lids and food debris removed. Labels do not have to be removed.
- Ferrous (iron, steel, tin) cans with food debris removed.
- Newsprint black and white or pigmented. Not bound or placed in bags.
- Construction paper, Kraft paper, cereal boxes, shoe boxes, or similar.
- Printer paper, computer paper, copy paper.
- Junk mail.
- Magazines, catalogs.
- Phone books.

Short list of materials not accepted:

- Pizza boxes.
- Wax-coated paper or cardboard.
- Plastic bags of any kind.
- Any material with food debris.
- Batteries of any kind.
- Styrofoam of any kind.
- Light bulbs.
- Mirrors, window or auto glass, porcelain, ceramics, glass cookware/bakeware, microwave oven trays, drinking glasses, perfume/cologne bottles.
- Un-numbered plastics.
- Wire coat hangers.
- Household items such as toasters, cookware, bakeware, electronics, appliances, etc.
- Hazardous or toxic substances.
- Items containing or having debris and residue containing hazardous or toxic substances such as paint cans with wet paint, motor oil containers, gasoline cans, glue, petroleum products, etc.
- Glass food and beverage containers.
- Aerosol cans.
