

**NOTICE OF PUBLIC HEARING**  
**WAYNESBORO, PA – FRANKLIN COUNTY, PENNSYLVANIA**  
**MODIFICATIONS TO THE FY 2022 AND FY 2023 CDBG PROGRAM YEARS**

Notice is hereby given by the Borough of Waynesboro that a Public Hearing will be held on December 3, 2025 at 3:00 PM, prevailing time, in the Waynesboro Borough Building, Borough Council Chambers, 55 East Main Street, Waynesboro, PA 17268. The Borough Building is accessible to handicapped persons. Persons requiring special accommodation to participate in the public hearing may call the Borough Secretary's Office at 717-762-2101, Extension 225, to make those arrangements. Persons with hearing and/or speech impairments may contact the Borough through the PA Telecommunications Relay Service at 1-800-654-5984 or 7-1-1 to make arrangements.

The purpose of the Public Hearing is to present the Borough's Proposed Modifications to its FY 2022 and FY 2023 Community Development Block Grant (CDBG) Program Years.

The Borough is proposing the following modifications:

**FY 2022 CDBG Program Year**

1. Reduce the Philadelphia Avenue Street Improvements Project (W.Third St. to W. Fourth St.) line item activity amount from \$95,311.39 to a revised budget amount of \$85,415.32. This is a multi-year activity being funded by FY 2021 and FY 2022 CDBG Program Years. The cost of the project came in lower than expected. There is a balance of \$9,896.07 that needs to be reallocated.
2. The Borough is proposing to add a new activity to fund the N. Potomac Street (W. North St. to King St.) Project in the amount of \$9,896.07. This will be a multi-year activity with FY 2023 and FY 2024 funds.

**FY 2023 CDBG Program Year**

1. Reduce the West Third Street Improvements Project (S. Price Avenue to Fir Spring Drive) line item activity amount from \$141,010.00 to a revised budget amount of \$132,163.92. This is a multi-year activity being funded by FY 2022 and FY 2023 CDBG Program Years. The cost of the project came in lower than expected. There is a balance of \$8,846.08 that needs to be reallocated.
2. The Borough is proposing to add a new activity to fund the N. Potomac Street (W. North St. to King St.) Project, in the amount of \$8,846.08. This will be a multi-year activity with FY 2022 and FY 2024 funds.

All interested residents are encouraged to attend and will be afforded the opportunity to give oral testimony or to present written comments on the proposed modification.
