JULY 21, 2021 WAYNESBORO, PA 17268 <u>PUBLIC HEARING RE: PROPOSED</u> <u>AMENDMENTS TO STORMWATER</u> <u>MANAGEMENT REQUIREMENTS</u>

Council President C. Harold Mumma called the public hearing of the Waynesboro Borough Council to order at 6:30 p.m. with the following in attendance:

Solicitor Wiser noted that the purpose of the public hearing is to consider and receive public comment on an ordinance amending the Borough of Waynesboro's Stormwater Management Ordinance. If enacted, the ordinance will address the post-development peak runoff rate and infiltration practices. The proposed ordinance provides that any post-development areas designed to initially be, or existing as, gravel or crushed stone shall be considered impervious for the purpose of comparison to the exemption criteria, redevelopment peak runoff rates, and respective release dates.

Kevin Grubbs provided testimony in regard to the proposed amendment to Stormwater Management Ordinance No. 961 and timeline of events, as follows –

- <u>May 10, 2021</u> The Waynesboro Planning Commission reviewed the proposed amendment and recommended approval to Borough Council.
- <u>May 19, 2021</u> Borough Council approved advertisement of ordinance for adoption.
- June 25, 2021 Received Legal Notice of Publication/Ordinance Summary for advertisement of the Public Hearing scheduled for July 21, 2021 at 6:30 p.m. from the Solicitor.

Received amendment to the Stormwater Management Ordinance from the Solicitor.

 June 28, 2021 – Sent attested copy of the amendment to the Stormwater Management Ordinance and Legal Notice of Publication to the Franklin County Law Library for filing.

Sent attested copy of the amendment to the Stormwater Management Ordinance and Legal Notice of Publication to the Franklin County Planning Commission for review and comments.

Received review letter from Franklin County Planning Commission on proposed amendment to the Stormwater Management Ordinance. Franklin County Planning Commission recommended approval of the amendment to the ordinance.

• June 30, 2021 – Melinda Knott, Office Manager, sent Notice of Publication with the Ordinance Summary to *The Record* Herald newspaper for publication on July 6, 2021 and July 13, 2021.

Comments from Council and the public were then requested. There were none.
