**CALL TO ORDER:** Mayor Starliper called the re-organization meeting of the incoming Borough Council to order.

## <u>UNFINISHED BUSINESS</u>

RESOLUTION NO. 2021-28 AUTHORIZING THE ENTRY INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT WITH WASHINGTON TOWNSHIP TO PROVIDE FIRE PROTECTION SERVICE: Mr. Stains noted that Washington Township Supervisors met this afternoon and passed this same resolution to enter into an agreement with the Borough of Waynesboro for fire protection service. He added that they have signed the proposed agreement with a minor change in Item 2 (Fire Service Area) to include a phrase that the parties would have to change box cards by mutual agreement.

He advised that the Township will pay the Borough the following amounts: 2022 - \$150,000; 2023 - \$166,843; and 2024 - \$185,380. The Fire Chief will continue to attend Township meetings and provide an overview of fire services provided in the Township over the past month. The Borough agrees to provide an electronic copy of its annual budget to the Township within 45 days of its adoption, as well as an electronic copy of its annual audited financial statements within 45 days of its completion. In addition, the Borough agrees that the Township may provide input regarding fire protection services desired by the Township, and Township representatives may attend budget meetings of the Borough where the Fire Department budget is developed. In the event that the Borough anticipates an unbudgeted expenditure in an amount of \$20,000 or more, the Borough will make the Township aware of the additional expenditure and allow the Township at least 10 business days to provide input to the Borough (emergency circumstances excluded). The Agreement will commence on January 1, 2022 and terminate December 31, 2024 unless mutually amended by the parties.

Councilman J. Fleagle made a motion for approval. Councilman Cermak seconded; the motion passed unanimously.

### **NEW BUSINESS**

**OPEN 2022 BUDGET:** Mr. Stains noted that, in accordance with the Borough Code, "new" Council has the right to re-open the 2022 budget; and if they choose to do so, the revised budget must be advertised and finalized by 02/15. No members expressed a desire to re-open the budget.

ACKNOWLEDGE AND APPROVE PERSONNEL MATTERS: Councilman Royer made a motion to approve personnel matters as recommended by the Personnel Committee. Councilman Cermak seconded; the motion passed unanimously.

EAW ENFORCEMENT AND CORRECTIONS RE-RELEASE BODY-WORN CAMERA POLICY AND IMPLEMENTATION PROGRAM SUBGRANT AGREEMENT BETWEEN COUNTY OF FRANKLIN AND THE WAYNESBORO POLICE DEPARTMENT: Mr. Stains noted that Council voted earlier in the meeting to add this item to the agenda for action. Franklin County is the recipient of funding from the PA Commission on Crime and Delinquency (PCCD), which announced the disbursement of state funds to PA municipalities, regional police departments and counties to support the implementation of Body Worn Camera programs. Franklin County has applied for and received funding in the amount of \$134,281, of which they have elected to award the Waynesboro Police Department a grant in the amount of \$29,632. Mr. Stains noted that this agreement has been vetted by the County's Solicitor, the Borough Solicitor, the Borough Manager and Police Chief. Councilman Cermak made a motion for approval. Councilman Knott seconded; the motion passed unanimously.

Police Chief Sourbier noted his appreciation to Council for authorizing an additional round of civil service examinations. He added that it is becoming increasingly more difficult to recruit new officers to the area, and he made several suggestions for Council to consider in the near future to make Waynesboro stand apart from the competition.

Councilman P. Fleagle and J. Fleagle agreed that if all parties work together, many things can be accomplished.

Council took a brief recess and went into executive session at 7:07 p.m. to discuss personnel and litigation matters. They reconvened at 8:13 p.m. and adjourned on a P. Fleagle/Royer motion which passed unanimously.
